

II. Annotations

1. The ninth session of the Meeting of the Parties to the Convention on the Protection and Use of Transboundary Watercourses and International Lakes (Water Convention) will be held from 29 September to 1 October 2021. Due to infection control measures and travel restrictions related to the coronavirus disease (COVID-19) pandemic, the meeting will be held in a hybrid format (i.e. with in-person and online participation) at the United Nations Office at Geneva. The meeting is organized in cooperation with the Government of Estonia. It will be a milestone for reviewing and accelerating progress towards achieving target 6.5 of the Sustainable Development Goals and discussing challenges and good practices related to transboundary water cooperation and the role of the Water Convention.

- 2. The Meeting will consist of a high-level segment and a general segment. The high-level segment, dealing with items 1 to 3 of the provisional agenda, will be held in the morning and early afternoon of Wednesday, 29 September, starting at 10 a.m. The general segment, covering items 4 to 23 of the provisional agenda, will take place from the afternoon of Wednesday, 29 September, until 5 p.m. on Friday, 1 October. The working languages will be Arabic, English, French, Russian and Spanish.
- 3. Additional practical information on the meeting, as well as all relevant documentation, will be posted on a dedicated page of the Convention's website¹ in due course.
- 4. Several side events will be organized on 27 and 28 September 2021, i.e. prior to the session. A detailed programme of these events will be available in September 2021.
- 5. In view of the expected large participation in the meeting and its hybrid format, participants are requested to limit the length of their interventions to three minutes during the high-level segment and two minutes during the general segment. Full statements provided to the secretariat will be posted on the session's web page.

High-level segment

1. Opening of the session and adoption of the agenda

- 6. Mr. Ardak Zebeshev (Chair of the Meeting of the Parties, Ministry of Foreign Affairs of Kazakhstan) will open the meeting.
- 7. A high-level representative of Estonia and a high-level representative of Kazakhstan will address the Meeting.
- 8. Statements by high-level representatives of the United Nations and the United Nations Economic Commission for Europe (ECE) will follow.
- 9. The Chair will invite the Parties to adopt the agenda as set out in the present document.
- 10. The Chair will also invite the Parties to take note of the document on procedural matters of relevance for decision-making at the ninth session of the Meeting of the Parties due to the extraordinary circumstances related to the coronavirus disease pandemic and decide to apply it during the session.

2. Status of ratification of the Convention and its Protocols and report on credentials. Progress in the global opening of the Convention

Tentative timing: Wednesday, 29 September, 10.45–11 a.m.

- 11. The secretariat will inform the Meeting about the status of ratification of the Convention, the Protocol on Water and Health, the Protocol on Civil Liability and Compensation for Damage Caused by the Transboundary Effects of Industrial Accidents on Transboundary Waters and the amendments to articles 25 and 26 of the Convention.
- 12. In accordance with rules 14 and 15 of the rules of procedure (ECE/MP.WAT/54/Add.2), the Bureau will examine the credentials² submitted by Parties and submit its report to the Meeting. Parties to the Convention are requested to submit the credentials or a copy of them to the secretariat in advance of the session, preferably by 10 September 2021.
- 13. New Parties will be invited to report on their accession, followed by a small celebration.

3. Special session – Water and peace

Tentative timing: Wednesday, 29 September, 11 a.m.–1 p.m. and 3–4 p.m.

- 14. Water knows no borders, so cooperation among sectors, communities and countries is of vital importance for its management. The growing scarcity of water in many regions increases the competition between the needs of various water uses, including for human consumption, industry, energy production, agriculture and the environment. This can lead to tensions between different sectors, between different users of a watershed or between riparian States. In many areas, not being the sole source of dispute, competition over water has been a dispute intensifier. Disputes are already taking place in some regions, and pressures are increasing due to climate change, population growth, etc. However, water much more frequently represents a source of cooperation.
- 15. Governing transboundary waters in a cooperative, equitable and sustainable manner is thus critical for sustainable development, climate resilience, conflict prevention and peace. Implementation of the Water Convention shows that legal and institutional frameworks contribute to preventing and reducing the risks of conflict.
- 16. The high-level special session on "Water and Peace" will provide an opportunity to highlight and discuss the role of transboundary water cooperation in fostering trust, stability and peace. It will offer a high-level platform for an open dialogue on the role of water in sustainable development, regional integration, cooperation and peace in transboundary basins and beyond.

² Credentials are required for all Parties to the Convention (countries that are not Parties to the Convention do not need credentials). Credentials are normally issued by the Head of State or Government, the Minister for Foreign Affairs or, in the case of a regional economic integration organization, the competent authority of the organization, and must indicate the composition of the delegation, including the head of delegation, and state that the delegation is empowered to participate in the Meeting of the Parties and to take decisions on behalf of the respective Government or organization under the applicable rules of procedure. The credentials should list all official representatives of Parties, whether intending to participate in-person or online/remotely.

- 17. The session will present concrete experiences of Parties to the Water Convention and other countries and basins that will illustrate how transboundary water cooperation helps to prevent conflicts and promote and sustain peace. It will reflect on how accession to the Convention and its implementation can contribute to peace, and how to make best use of the Convention.
- 18. On the basis of the findings of the second reporting exercise on indicator 6.5.2 of the Sustainable Development Goals, the session will also debate how to accelerate progress to tackle persisting challenges in transboundary water cooperation to achieve Sustainable Development Goals 6, on water, and 16, on peace, and in particular target 6.5 of the Sustainable Development Goals, on the implementation of integrated water resources management, including through transboundary cooperation, in line with the SDG 6 Global Acceleration Framework.
- 19. The special session will provide an opportunity for a strategic discussion between Parties, other States including prospective Parties from all regions, international organizations, non-governmental organizations, international financial institutions and other stakeholders. It will consist of two thematic parts:
 - (a) Transboundary water cooperation: a catalyst for peace;
- (b) Accelerating progress on transboundary water cooperation to achieve sustainable development.
- 20. The special session will be organized as a combination of discussions in the form of moderated thematic panels and high-level contributions from the floor. A provisional programme of the high-level segment will provide further details on the themes and speakers.
- 21. Panellists and high-level interventions from the floor³ will focus on the following questions:
- (a) What can we learn from experiences of basins and regions where water has become a catalyst for peace between neighbours?
- (b) How can we promote effective water cooperation in order to strive for peace in transboundary basins, especially those affected by tensions and conflicts?
- (c) How does accession to the Water Convention and its implementation in countries and basins help to prevent disputes and sustain peace and stability?
- (d) How can the development of operational arrangements and the establishment of joint bodies for transboundary water resources management contribute?
- (e) How can the best use be made of the Water Convention and its tools and bodies in the prevention and resolution of water-related disputes?
- (f) What is needed to accelerate progress towards achieving Sustainable Development Goal 6, and in particular its target 6.5, a requirement for sustainable development and a key to ensuring peace and stability?
- (g) What is needed to support States Members of the United Nations in acceding to, implementing and complying with the two global United Nations water conventions?

4. Increasing awareness of and accession to the Convention and application of its principles drawing on the benefits of cooperation

Tentative timing: Wednesday, 29 September, 4–6 p.m., and Thursday, 30 September, 10–10.50 a.m.

- 23. The Meeting will review progress made in fostering the application of the principles of the Convention and support provided to countries to this end in the context of the global opening of the Convention and discuss further action in this area of work.
- (a) Progress in national processes towards accession and implementation of the Strategy for the implementation of the Convention at the global level

Tentative timing: Wednesday, 29 September, 4–5 p.m.

- 24. The triennium 2019–2021 was marked by increased progress in accession processes in countries in Africa, as well as in other regions. New Parties and countries in the process of accession will be invited to inform the Meeting about their progress and lessons learned from the accession process, as well as plans for implementing the Convention. Partners having supported these processes will be invited to comment.
- 25. The Meeting will be informed about: activities carried out by the secretariat, the Bureau, countries and partners in 2019–2021 to implement the Strategy for the

implementation of the Convention at the global level (ECE/MP.WAT/54/Add.2); the publication *Frequently Asked Questions on the 1992 Water Convention, with the Road map to facilitate accession processes*, prepared to support the global opening; and efforts to raise awareness of the Water Convention and the Convention on the Law of the Non-navigational Uses of International Watercourses at the national, basin, regional and global levels, including the UN-Water policy brief *The United Nations global water conventions: Fostering sustainable development and peace* published to support these efforts.

26. Participants will discuss future activities designed to support national processes towards accession to and implementation of the Water Convention, as well as how to promote further implementation of the Strategy for the implementation of the Convention at the global level, to be carried out during the period 2022–2024.

(b) Launch of the second progress report on implementation of the Convention

Tentative timing: Wednesday, 29 September, 5–5.30 p.m.

- 27. At its seventh session (Budapest, 17–19 November 2015), through decision VII/2 (see ECE/MP.WAT/49/Add.2), the Meeting of the Parties introduced a regular reporting mechanism under the Convention. In 2020–2021, as part of the second reporting exercise on indicator 6.5.2 of the Sustainable Development Goals and under the Water Convention, all Parties to the Convention have submitted their national reports. In 2021, in line with decision VIII/1 on reporting under the Convention (see ECE/MP.WAT/54/Add.2), the secretariat prepared the publication "Progress on transboundary water cooperation under the Water Convention: Second report on implementation of the Convention on the Protection and Use of Transboundary Watercourses and International Lakes" (ECE/MP.WAT/67) based on the information contained in the national reports of the Parties. The report will be presented and launched.
- 28. The Meeting will be invited to discuss key achievements, including the signature of new agreements, and challenges for implementation of the Convention identified in the second progress report and the way forward to strengthen implementation of the Convention and transboundary water cooperation.

(c) Supporting the development of agreements and the establishment of joint bodies

- 29. The Meeting will review the publication "Practical guide on the development of agreements or other arrangements for transboundary water cooperation" (ECE/MP.WAT/68), prepared by a dedicated drafting group following the virtual workshop on designing legal frameworks for transboundary water cooperation (28 and 29 July 2020) and subsequently finalized based on comments and inputs provided by countries and stakeholders. The Meeting will be invited to endorse the publication. It will also discuss how to promote the use of the tool and further develop it in the next triennium.
- 30. The Meeting will discuss future activities to support the development of agreements and the establishment of joint bodies promoting different tools developed under the Convention and facilitating the exchange of experiences.

- 34. The Meeting will discuss progress achieved in supporting implementation or application of the Convention through projects on the ground and capacity-building in different basins such as the Drin, Dniester, Chu-Talas, Kura and Neman River basins and the Senegal-Mauritanian Aquifer basin and at the regional level, for example in Central Asia.
- 35. The Meeting will discuss possible future activities to support the development of agreements and strengthening of institutions, building on the benefits of transboundary cooperation.

5. Supporting monitoring, assessment and information sharing in transboundary basins

Tentative timing: Thursday, 30 September, 10.50-11.20 a.m.

- 36. The Meeting will discuss the monitoring and assessment activities carried out under the Convention in 2019–2021, including several activities on information exchange, monitoring and assessment in specific basins, the outcomes of the global workshop on exchange of data and information in transboundary basins (Geneva, 4 and 5 December 2019), the Expert Group Meeting on Monitoring, Assessment and Data Exchange (online, 1 April 2021) and other activities under the auspices of the Working Group on Monitoring and Assessment.
- 37. Participants will discuss future activities beyond 2021 to support countries in initiating or further developing joint or coordinated monitoring and assessment of transboundary waters and improving exchange of information and data.

6. Supporting equitable and sustainable water allocation in the transboundary context

Tentative timing: Thursday, 30 September, 11.20 a.m.-12.10 p.m.

- 38. Following the decision of the Meeting of the Parties at its eighth session (Nur-Sultan, 10–12 October 2018) to develop a handbook on water allocation in the transboundary context (see ECE/MP.WAT/54/Add.1), a publication "Handbook on water allocation in a transboundary context" (ECE/MP.WAT/64) was prepared in 2019–2021 with support from an Expert Group and subsequently finalized based on comments and inputs provided by countries and other stakeholders. The Meeting will review and endorse the publication.
- 39. The Meeting will discuss how to promote the use of the handbook and discuss future activities on water allocation in a transboundary context beyond 2021.

7. European Union Water Initiative and National Policy Dialogues

Tentative timing: Thursday, 30 September, 12.10-1 p.m.

- 40. The Meeting will discuss progress on the European Union Water Initiative (EUWI+) National Policy Dialogues on Integrated Water Resources Management in supporting water sector reforms and the achievement of Sustainable Development Goals in countries of Eastern Europe, the Caucasus and Central Asia.
- 41. Participants will examine lessons learned from the Dialogues and discuss future development of the Dialogues beyond 2021 within the framework of the follow-up action to the European Union Water Initiative Plus programme for the Eastern Partnership countries, implemented jointly by ECE, the Organisation for Economic Co-operation and Development, Environment Agency Austria and the International Office for Water of France, and a regional project in Central Asia, funded by the European Union within the regional European Union Central Asia Cooperation on Water, Environment and Climate Change programme, including links with other programme areas under the Convention.

8. Water-food-energy-ecosystems nexus in transboundary basins

Tentative timing: Thursday, 30 September, 3–3.45 p.m.

- 42. The Meeting will be informed of the work carried out in the transboundary basins, applying the methodology for assessing the water-food-energy-ecosystems nexus in transboundary basins, namely in the Drina River basin (follow-up), the North-Western Sahara Aquifer System and the Drin River basin, and the activities of the Task Force on the Water-Food-Energy-Ecosystems Nexus. Two publications will be presented: Toolkit publication *Towards sustainable renewable energy investment and deployment: Trade-offs and opportunities with water resources and the environment*, developed in 2020 in cooperation with the ECE Sustainable Energy Division; and a synthesis publication "Solutions and investments in the water-food-energy-ecosystems nexus: synthesis of nexus solutions" (ECE/MP.WAT/66), which will be launched at the meeting.
- 43. Participants will discuss future work in this area beyond 2021 to further promote the methodology for assessing the water-food-energy-ecosystems nexus in transboundary basins and to operationalize nexus solutions.

9. Facilitating financing of transboundary water cooperation

Tentative timing: Thursday, 30 September, 3.45-4.30 p.m.

- 44. Participants will review the activities under the programme area on financing of transboundary water cooperation, as a part of which the publication "Funding and financing of transboundary water cooperation and basin development" (ECE/MP.WAT/61) was developed through a consultative process, and a virtual workshop on financing transboundary water cooperation and basin development was organized on 16 and 17 December 2020 in cooperation with the Netherlands, Senegal, Switzerland, the African Development Bank, the Asian Development Bank, the European Investment Bank, the Global Environment Facility and its International Waters Learning Exchange and Resource Network (IW:LEARN), the Inter-American Development Bank, OECD, the United Nations Capital Development Fund, the World Bank Group and the World Wildlife Fund. The publication will be presented. Participants, in particular, international financial institutions and other partner organizations, will discuss how to use this publication to raise awareness on financing of transboundary water cooperation and basin development, as well as to support mobilization of funding and financing in shared basins.
- 45. The Meeting will discuss future activities beyond 2021 to: raise awareness and facilitate knowledge-sharing on the importance of enhancing the financial sustainability of transboundary water cooperation and management; and support national authorities and joint bodies in shaping their strategies for mobilizing financial resources.

10. Reporting under the Convention and on indicator 6.5.2 of the Sustainable Development Goals

Tentative timing: Thursday, 30 September, 4.30-5.25 p.m.

- 46. The introduction of reporting under the Convention coincided with the adoption of the Sustainable Development Goals and their targets in 2015. Target 6.5 calls for countries to implement integrated water resources management at all levels, including through transboundary cooperation as appropriate. In order to measure progress, indicator 6.5.2 (Proportion of transboundary basin area with an operational arrangement for water cooperation) was agreed by the United Nations Statistical Commission in March 2016⁵ and subsequently adopted by the General Assembly in July 2017 as part of the global indicator framework for the Sustainable Development Goals and targets of the 2030 Agenda for Sustainable Development. ECE and the United Nations Educational, Scientific and Cultural Organization (UNESCO) have led the development of the step-by-step methodology for calculating indicator 6.5.2 and have been entrusted as "custodian agencies" for the indicator.
- 47. In order to maximize synergies and efficiencies, at the eleventh meeting of the Working Group on Integrated Water Resources Management (Geneva, 18 and 19 October 2016), it was decided to combine reporting under the Convention and reporting on indicator 6.5.2 and to send all Parties a single template for the provision of this information. Similarly, all countries sharing transboundary waters were invited to report on indicator 6.5.2 through a questionnaire which, in addition to a section on calculation of the indicator, includes three other sections that provide descriptive information, help substantiate whether the

operationality criteria are met and provide the opportunity to report on informal forms of cooperation. This makes it possible to gain a full picture of the status of transboundary water cooperation, track progress more closely beyond the indicator value and establish the current baseline with greater accuracy. Two reporting exercises have been carried out to date, in 2017–2018 and in 2020–2021. In the second round, 129 replies were received out of the 153 countries worldwide sharing transboundary waters.

- 48. The Meeting will be informed about progress and future planned activities on the integrated monitoring of water- and sanitation-related targets of the Sustainable Development Goals under the Integrated Monitoring Initiative for SDG 6, operating under the aegis of UN-Water, and the findings of the Summary Progress Update 2021: SDG 6 water and sanitation for all.
- 49. The Meeting will be presented with and will discuss the outcomes of the second reporting exercise on indicator 6.5.2 of the Sustainable Development Goals and under the Convention for Parties conducted in the period 2020–2021. It will be informed of the guidance tools developed and support provided to the countries in the second reporting exercise by ECE and UNESCO as co-custodian agencies. Representatives of ECE and UNESCO will present activities to support reporting on indicator 6.5.2.
- 50. Building on the findings of the report "Progress on transboundary water cooperation: Global status of SDG indicator 6.5.2 and acceleration needs 2021", presented during the high-level segment, and the report "Progress on transboundary water cooperation under the Water Convention: Second report on implementation of the Convention on the Protection and Use of Transboundary Watercourses and International Lakes", launched under agenda item 4 (b), participants will engage in a forward-looking discussion on how to use the results of reporting to enhance transboundary cooperation and support the achievement of target 6.5 of the Sustainable Development Goals, in line with the SDG 6 Global Acceleration Framework.
- 51. The Meeting will then discuss the establishment of an online reporting mechanism and be invited to review and adopt the draft decision on reporting (ECE/MP.WAT/2021/6).
- 52. Lastly, the Meeting will discuss future work in this area beyond 2021.

13. Adapting to climate change in transboundary basins

- 58. The Meeting will be informed of the work on adaptation to climate change in transboundary basins carried out since 2019 under the overall guidance of the Task Force on Water and Climate.
