

## Sacos de Plástico Leves (SPL)

De acordo com o n.º 5, do artigo 97.ºA do UNILEX, a partir de 1 de julho de 2021, a APA, I. P., publicita os resultados de gestão alcançados a nível nacional para cada fluxo específico de resíduos, até cinco dias úteis após a validação pela Comissão Europeia do reporte previsto.

A tabela infra demonstra o resumo do reporte comunitário efetuado em 2025 relativamente a 2023. O consumo anual de sacos de plástico de leves é calculado de acordo com a decisão estabelecida no artigo 2(1)(b) da [Decisão de Execução 2018/896 da Comissão](#), de 19 de junho de 2018.
